**The consumer confidence indicator decreases and the economic climate indicator increases**

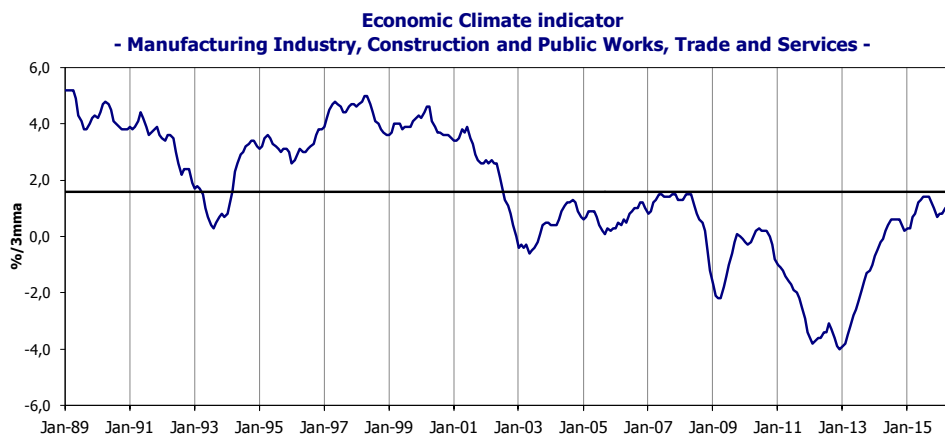
The Consumer confidence indicator decreased in June and July, after increasing in May.

The economic climate indicator increased in July, after stabilizing in the previous month. In the reference month, the confidence indicators increased in Manufacturing Industry, in Construction and Public Works and in Trade and decreased in Services.

The evolution of the Consumer<sup>1</sup> confidence indicator in July reflected the negative contribution of the perspectives on the evolution of the country's economic situation and the unemployment.

In Manufacturing Industry, the confidence indicator increased in June and July, reflecting in the last month the positive contribution of the opinions on global demand. In Construction and Public Works, the confidence indicator increased in July, after decreasing tenuously in the previous month, due to the positive evolution of the opinions on the order books'. The confidence indicator for Trade increased between April and July, reflecting the positive contribution of all components in the last four months, perspectives on the business activity and opinions on the volume of stocks and on the sales evolution. On the contrary, the Services' confidence indicator decreased between May and July, reflecting in the last month the negative contribution of the opinions on the order books' evolution and on the business activity.

## Notes

The Business and Consumer Qualitative Surveys published by Statistics Portugal are developed in the framework of the harmonized EU Business and Consumer Surveys Programme of the European Commission (EC) DG-ECFIN (*Directorate-General for Economic and Financial Affairs*) and are financially supported in the framework of the agreement signed between these two institutions. The questionnaires are harmonized among the European countries, as well as the respective confidence indicators' methodology. The surveys' results are sent to the EC in effective values, and, therefore, the seasonally adjusted values published by the EC are computed by this entity and presented without using three months moving averages. **The text and graphics of this press release are based on three terms moving averages, for the monthly variables, and two terms, for the quarterly variables, and on original values, except the cases of the seasonally adjusted series. The seasonal adjustment uses the X13-Arima method (combination of moving averages process and auto-regressive integrated moving average models) developed in the JDemetra+<sup>2</sup> software provided by Eurostat. This application relies on the use of probabilistic models to correct seasonal effects from the original series. The seasonal treatment is updated in May, for monthly and quarterly series, which might result on a revision of the series previously published. The use of moving averages smoothes out the series by removing the irregular movements, allowing the detection of the short-term trends. Since the average is not centred (the information is used to analyse the evolution of the last month) there is a small lag compared with the trend that is supposed to detect.**

**In order to compare the difference between original and moving average series, the graphical representation of the confidence indicators presents both types of series. The average of the economic climate indicator is computed from the beginning of the series to the reference month.**

The balances of the questions are the difference between the positive and negative answers, that is  $\text{Balance} = \% \text{answer (+)} - \% \text{answer (-)}$ . In the Consumer Survey there are questions with more than one option of positive/negative answer. In these cases, to the most positive/negative answers is given the weight 1 and to the others the weight 0.5, that is  $\text{Balance} = [\% \text{answer (++)} * 1 + \% \text{answer (+)} * 0.5] - [\% \text{answer (--)} * 1 + \% \text{answer (-)} * 0.5]$ . The percentage of answers that correspond to "equal" is not considered.

### ECONOMIC CLIMATE INDICATOR

Synthetic Indicator estimated using balances of questions from the Manufacturing Industry, Trade, Construction and Public Works and Services Surveys. The method for this indicator uses the factor analysis and the estimated series (the common component) is calibrated using the GDP change rates. The questions that integrate the indicator are:

- Qualitative Manufacturing Industry survey
  - How has your production developed over the past 3 months? It has... 1. + increased; 2. = remained unchanged; 3. - decreased.
  - Do you consider your current overall order books to be...? 1. + more than sufficient (above normal); 2. = sufficient (normal for the season); 3. - not sufficient (below normal).
  - Do you consider your current export order books to be...? 1. + more than sufficient (above normal); 2. = sufficient (normal for the season); 3. - not sufficient (below normal).
  - Do you consider your current stock of finished products to be...? 1. + too large (above normal); 2. = adequate (normal for the season); 3. - too small (below normal).
  - How do you expect your production to develop over the next 3 months? It will... 1. + increase; 2. = remain unchanged; 3. - decrease.
