

THE CPI ANNUAL AVERAGE RATE OF CHANGE WAS 1.3% IN 2021 AND THE RATE OF CHANGE ON A YEAR EARLIER WAS 2.7% IN DECEMBER

In 2021, the average rate of change of the Portuguese Consumer Price Index (CPI) was 1.3% (nil in 2020). Excluding energy and unprocessed food, the average rate of change was 0.8% in 2021 (nil in the previous year). The rate of change on a year earlier of total CPI presented a pronounced upward trend during 2021, in particular in the second half of the year where the rates of change were always above the annual average rate.

The CPI annual rate was 2.7% in December (2.6% in November). Compared to the flash estimate published on January 3rd, there was a downwards revision by 0.02 percentage points, leading to a revision of the CPI rate of change on a year earlier in December from 2.8% to 2.7% due to rounding procedures. The annual core inflation rate, which excludes energy and unprocessed food products components, was 1.8% (1.7% in the previous month). The CPI monthly rate was nil (0.4% in November and -0.1% in December 2020).

In 2021, the annual average rate of change of the Portuguese Harmonised Index of Consumer Prices (HICP) was 0.9% (-0.1% in 2020). In December 2021, the HICP annual rate of change was 2.8% (2.6% in the previous month). This rate is 2.2 percentage points (p.p.) below the figure estimated by Eurostat for the Euro area (in November, this difference was 2.3 p.p.).



CONSUMER PRICE INDEX – December 2021

Consumer Price Index (base 100 = 2012)¹

The annual average rate of change of the Portuguese Consumer Price Index (CPI) was 1.3% in 2021 (nil in 2020). The annual average core inflation rate, which excludes unprocessed food and energy, was 0.8% (nil in 2020).




Fig. 2 - Breakdown of the contributions for the CPI annual average rate of change

The increase of the average rate of change of the CPI between 2020 and 2021 was influenced by the behaviour of core inflation and the positive evolution of the prices of energy (see Fig. 2). In 2021, the average rate of change of these aggregates was 0.8% and 7.3% respectively (0.0% and -5.0% in 2020). The prices of unprocessed food increased by 0.6%, below the rate observed in the previous year (4.0%).

In December 2021, the annual inflation rate was 2.7% (2.6% in November) (see Fig. 1). Compared to the flash estimate published on January 3rd there was a downwards revision by 0.02 percentage points, leading to a revision of the CPI rate of change on a year earlier in December from 2.8% to 2.7% due to rounding procedures (for further details on the differences between estimated and final CPI figures, see Table 2 on page 5 of this press release).

The annual core inflation rate, which excludes energy and unprocessed food products, was 1.8% (1.7% in November). The energy aggregate presented an annual rate of 11.2% (14.1% in the previous month), while unprocessed food recorded an annual rate of 3.2% in December (0.8% in November).

The largest upward contribution to the overall annual rate of change came from changes in the prices of *Transports* and *Food and non-alcoholic beverages*. In December, for the first time since May 2003, all divisions recorded positive annual rates of change.

CONSUMER PRICE INDEX – December 2021



In December 2021, the CPI monthly rate was nil (0.4% in the previous month and -0.1% in December 2020). The main upward contribution to the monthly rate of change came from price changes in *Food and non-alcoholic beverages*. Conversely, the only downward contribution was observed in *Clothing and footwear*.

Harmonised Index of Consumer Prices (base 100 = 2015)

In December 2021, the Portuguese HICP annual rate was 2.8% (2.6% in the previous month) and the monthly rate was nil (0.3% in the previous month and -0.1% in December 2020).

According to Eurostat's Flash Estimate, in December, the annual rate of change of the Portuguese HICP is estimated to be 2.2 p.p. lower than the Euro area rate (in November, this difference was 2.3 p.p.).



The HICP 12-month average rate was 0.9% in December (0.7% in November).

Housing Rents

In December, the annual change rate of the housing rents for the whole country was 1.9% (the same value as in the previous month). The highest increase was observed in the Algarve region (2.2%), with all regions displaying positive rates of change.

For the same period, the monthly rate of change of the average value of rents per square meter for the whole country was 0.1% (0.2% in November). The main increase was observed in the Algarve region (0.3%) while all the other regions also presented positive rates of change.

In 2021, the 12-month average rate of change for of the average value of rents per square meter of living area for the whole country was 1.8% (2.6% in 2020)². The main increase was recorded in the Lisboa region (1.9%) and all the other regions presented positive rates.

² It is important to note that the housing rents component of the CPI takes into account the full stock of rented dwellings and cannot be compared to the results of the *House rental statistics at local level*, that are also published by INE, for which only the new lease agreements are considered.

METHODOLOGICAL NOTES

CONSUMER PRICE INDEX

The Consumer Price Index (CPI) measures the change over time of the prices of a certain basket of goods and services bought by a "typical" consumer. The CPI has been designed to capture price changes and not to measure price levels.

The CPI is updated every year with the most recent information on prices and quantities. The 2020 CPI weighting structure and the sample of goods and services included in the basket are a result of the combination of three fundamental sources of information: results of the Portuguese National Accounts, complemented with the Household Budget Survey and the Census for more detailed levels of expenditure. Administrative data is also used.

The CPI is compiled through the aggregation of seven regional price indexes and the goods and services included in the index are grouped according to the Classification of individual consumption by purpose (COICOP).

MONTHLY RATE

The monthly rate is the change in the index of a certain month compared with the index of the previous month expressed as a percentage. Although up to date, this measure can be affected by seasonal and other effects.

ANNUAL RATE

The annual rate is the change in the index of a certain month compared with the index of the same month in the previous year expressed as a percentage. In the presence of a stable seasonal pattern, seasonal effects do not influence this measure.

12-MONTH AVERAGE RATE

The 12-month average rate is the change in the average index of one year compared with the average index of the previous year expressed as a percentage. This moving average is less sensitive to transient changes in prices.

CORE INFLATION INDEX (ALL ITEMS CPI EXCLUDING UNPROCESSED FOOD AND ENERGY PRODUCTS)

The core inflation index is compiled by excluding the prices of unprocessed food and energy products from the All items CPI. The primary objective of this index is to capture the underlying inflation pressures in the economy.

HARMONISED INDEX OF CONSUMER PRICES

The Harmonised Index of Consumer Prices (HICP) is compiled in each member state of the European Union for the purposes of inflation comparisons across EU countries, as required by the Treaty on European Union³. This index plays an important role as a guideline for the achievement of the European System of Central Banks primary objective: price stability. In 1998, the European Central Bank adopted the HICP as "the most appropriate price measure" for its definition of price stability in the Euro area⁴.

The HICP is produced in each Member State following a harmonized methodology developed by experts in the field of price statistics, under the "Price Statistics Working Group" and related Task Forces. From the methodological point of view, there are no major differences between the HICP and CPI. However, the different scope of coverage leads to differences in the weighting structure, mainly in Restaurants and hotels. This is mostly an effect of the inclusion of non-residents expenditure ("tourists") in the HICP and the corresponding exclusion from the CPI.

PRESENTATION OF DATA AND ROUNDING RULES

Since the release of the January 2013 CPI indices are published with base 100 in the year 2012.

Due to rounding procedures, those indices may not reproduce exactly the published rates of change. However, it should be noted that the published rates prevail.

In this press release the descriptive analysis is based on rounded values to one decimal

DIFFERENCES BETWEEN ESTIMATED AND FINAL VALUES

In Table 2 some descriptive statistics are presented for the differences between the estimated and final values of the annual rate for the last 24 months. The table also includes the differences for the last three months, in p.p..
