



## **Executive Summaryof Statistics Portugal and ONA Annual Work Programme 2022**

Instituto Nacional de Estatística I.P. (Statistics Portugal) shall pursue, in 2022, its Mission to produce, in an independent and impartial manner, high-quality official statistical information, relevant to society, promoting the coordination, analysis, innovation and dissemination of national statistical activity, ensuring the integrated storage of data, in accordance with the principles of the European Statistics Code of Practice.

The activity of Statistics Portugal is framed by the strategies of the National and European Statistical Systems oriented towards the promotion of official statistics as a public good and towards the satisfaction of emerging user needs, in new domains. These priorities will be supported by taking advantage of new data sources, public and private entities, using new technologies and applying new methods.

In 2022, Statistics Portugal will continue with its strategy to develop the National Data Infrastructure, with a view to taking advantage of information already available through administrative means and with potential usefulness for the production of official statistics and for research purposes, in close coordination with the entities that hold the data.

The development of projects presented in the context of StatsLab - Statistics under Development, a space where new statistical products are presented before they acquire their final format and which make use of new statistical processing techniques, will be continued.

In terms of Data Protection and Information Security, the development of Statistics Portugal's Information Security Management System will continue.

In the context of the production of official statistics, indicators contributing to the analysis of the social and economic impact of the epidemiological situation of COVID-19 will continue to be made available.

The Statistics Portugal's portal will continue to be the privileged dissemination and communication channel, while maintaining its commitment to continuous improvement with solutions and functionalities for a better organisation of contents and access to information. Also noteworthy are the activities on statistical literacy for various target audiences and the implementation of functionalities for extracting information in various formats from the Dissemination Database, favouring the Open Data approach.

Also noteworthy is the production and dissemination of a significant set of other statistical activities, representative of various domains, complying with reporting obligations and methodological requirements established by European and national statistical legislation, namely:

- Dissemination of final data from the 2021 Census (16th General Population Census and 6th General Housing Census).
- Continued development of the Resident Population Database (BPR).
- Revision of the Inter-census Estimates of the Resident Population.
- Completion of the pilot Survey on the Conditions, Origins and Paths of the Population Living in Portugal and start of the main statistical operation.
- Dissemination of 2021 annual and biennial estimates of new variables from the Labour Force Survey.
- Dissemination of the results of the regular module of the 2021 Labour Force Survey on the "Situation of Migrants and their descendants in the labour market".
- Implementation of the 2022 Labour Force Survey's modules on "Professional skills" (ad hoc module) and on "Employment in Digital Platforms" (exceptional module).
- Collection of data from the 2022 Household Budget Survey.
- Dissemination of the results of the 2021 Survey on Income and Living Conditions modules on "Health and material deprivation of children" and on "Living conditions and situation of children living in separated or reconstituted households".
- Implementation of the 2022 Survey on Income and Living Conditions modules on "Health" and "Quality of life".
- Dissemination of the results of the 2020 Household Finance and Consumption Survey and planning of the next edition (in articulation with Bank of Portugal).
- Implementation of the 2022 Adult Education Survey, which will be collected between 2022 and 2023.
- Continued improvement of the Gender dossier through the incorporation of statistical information relevant to the observation of inequalities between men and women.
- Dissemination of the results of the Entertainment Venues Survey (biennial).





- Development of health statistics, namely Hospital Statistics and Primary Health Care Statistics based on administrative data, integrated in the National Data Infrastructure.
- Dissemination of the results of the European System of Integrated Social Protection Statistics exercises: 2020 ESSPROS (financial data and pension beneficiaries) and 2019 ESSPROS (regarding net benefits).
- Implementation of the 2022 Survey on Safety in Public and Private Spaces.
- Continued implementation of the "Territorial Cohesion and Services of General Interest" project in support of the 2021 2027 cohesion policy programming cycle.
- Dissemination of the results of the National and Regional Accounts: final results for 2020 and the provisional version for 2021.
- Compilation of the Input/Output Matrix for 2020.
- Dissemination of Public Administrations accounts within the scope of the Excessive Deficit Procedure.
- Dissemination of the results of regular Satellite Accounts, namely in the areas of Tourism, Health, Environment and Agriculture.
- Dissemination of the results of the Culture Satellite Account.
- Continued dissemination of GDP flash estimates at 30 days after the reference quarter, detailed data by industry at 60 days and data by institutional sector at 85 days.
- Extension to new economic activities of the data collection for the compilation of the Services Production Price Index.
- Implementation of a new edition of the Framework Regulation Costs Survey in 2022, including in this edition additional questions regarding the impacts of the COVID-19 pandemic on context costs affecting companies.
- Continuation of the dissemination of the quarterly flash estimate of International Trade (at 28 days after the reference period),
   responding to the dissemination of the quarterly GDP flash estimate.
- Continued production and dissemination of the Survey on Prospects for the Export of Goods.
- Preparation of the 2023 Farm Structure Survey.
- Dissemination of the first national statistical exercise on quantifying food waste.
- Preparation of a new edition of the study on "The housing stock and its rehabilitation: analysis and evolution", within the scope of the analysis of the results of the 2021 Housing Census.
- Beginning of the collection of the Passenger Road Transport Survey following work to reformulate the survey.
- Implementation and dissemination of the 2022 Information and Knowledge Society Business Survey, with new modules:
   Human Resources and Information and Communication Technologies (ICT) Skills; ICT Security; Use of Robotics; ICT and the Environment.

Of the activities to be carried out by the ONA, the following stand out:

- Continuation of the assessment of information and procedures for the production of statistics in the area of Occupational Diseases [GEP/MTSSS]
- Dissemination of the 2020 Community Innovation Survey, with the main results anticipated for the 2nd quarter of 2022 [DG-EEC/Med|MCTES]
- Development and implementation of the Education and Science Statistics Portal [DGEEC/Med|MCTES]
- Availability of the "75 years of Education Statistics in Portugal" and "25 years of Science Statistics in Portugal" portraits [DG-EEC/Med|MCTES]
- Continued strengthening of the analysis of administrative data sources in the area of Justice and promotion of their use for statistical purposes by taking advantage of new data collection methods [DGPJ/MJ]
- Optimisation of the usability and graphic design of the new online consultation system of Justice statistics, integrated in the conception of the project to build a new platform for Justice statistics, within the scope of the Recovery and Resilience Plan [DGPJ/MJ]
- Continued strengthening of the quality of official statistics and increase of the efficiency of the statistical production process in the fisheries and aquaculture sector through methodological, scientific and technological development [DGRM/MM]
- Continuation of the identification of indicators and needs for the collection of periodic information for the follow-up and monitoring of the Energy and Climate National Integrated Plan (PNEC 2021-2030), in accordance with EUROSTAT guidelines, in order to enable the European Commission to verify compliance with the objectives associated with the European Green Deal. In summary, for Statistics Portugal and the EDCs, 317 statistical activities are envisaged (242 by Statistics Portugal and 75 by the EDCs); of which 280 are statistical operations (205 by Statistics Portugal and 75 by the EDCs), corresponding to 1,139 moments of making information available to society (814 by Statistics Portugal and 325 by the EDCs).





In terms of international statistical cooperation, Statistics Portugal will continue its participation and cooperation in various structures:

- Active participation in European structures, in particular those of the European Statistical System, namely in its Committee.
   The 3rd round of Peer Review to Statistics Portugal and the ONA within the scope of the implementation of the European Statistics Code of Practice should be highlighted.
- Active participation in the work of Eurostat's ESSnets and Task Forces in various domains.
- Participation in the European Statistical Forum, which brings together the European Statistical System and the European System of Central Banks.
- Follow-up on the 2030 Agenda for Sustainable Development, particularly with regard to monitoring indicators.
- Participation in international statistical fora representing Portugal, namely the United Nations Statistical Commission, the Conference of European Statisticians of the United Nations Economic Commission for Europe and the OECD Statistical Committee.
- Cooperation to develop the statistical systems of other countries, particularly Portuguese-speaking countries, both bilaterally
  and within the framework of the CPLP, in compliance with the commitments that have been made.

## At the human resources level

The implementation of the Activity Plan for 2022 of Statistics Portugal and the Entities with Delegated Powers foresees 794 employees:

- Statistics Portugal: 687 employees (senior staff, administrative and other assistants), according to the 2022 staff map.
- EDC: 107 employees.

## At the financial resources level

The implementation of this Activity Plan will involve a total budgeted cost of 38.709 million euros:

- Statistics Portugal: 34.304 million euros;
- EDC: 4.405 million euros.
