## GUESTS AND OVERNIGHT STAYS EXCEED 2019 LEVELS

The **tourist accommodation sector**<sup>1</sup> registered 3.0 million guests and 8.6 million overnight stays in **July 2022**, corresponding to year-on-year rates of change<sup>2</sup> of +85.4% and +90.1%, respectively (+97.6% and +110.7% in June, in the same order). Compared to July 2019, there were increases of 6.3% and 4.8%, respectively.

In July, the domestic market contributed with 2.9 million overnight stays (+9.1%) and the external markets amounted to 5.7 million (+205.2%). Compared to July 2019, the domestic market grew by 15.8% and external markets reached the same level as in 2019.

In the **first seven months of 2022**, overnight stays increased by 194.3% (+58.5% in residents and +406.2% in non-residents). Compared to the same period in 2019, overnight stays decreased by 4.4% (-9.4% for non-residents and +7.8% for residents).

In July, 12.8% of tourist accommodation establishments were closed or had no movement of guests (22.1% in July 2021).
