

14 October 2022 VITAL STATISTICS – Monthly data September 2022

DEATHS, LIVE BIRTHS AND MARRIAGES

IN AUGUST, THE NUMBER OF LIVE BIRTHS INCREASED 5.3% WHEN COMPARED TO THE SAME MONTH OF 2021

In September 2022, the number of deaths was 8,705, a figure lower than that registered in August 2022 (576 fewer deaths; -2.2%) and higher than the figure observed in September 2021 (132 more deaths; +1.5%). From January to September 2022, there were 92,724 deaths, 1,186 fewer than in the same period of 2021 (-1.3%).

In September 2022, the number of deaths due to COVID-19 decreased to 178 (50 fewer deaths than in August 2022), accounting for 2.0% of all deaths. Compared with September 2021, there was a decrease of 45 deaths due to COVID-19.

In August 2022, 7,537 children were born alive, corresponding to an increase of 5.3% compared to August 2021 (7,159). The total number of live births registered in the first eight months of 2022 (53,954) was higher than the value observed in the same period of 2021 (52,218), representing a further 1,736 (+3.3 %) live births.

In August 2022, the natural balance was -1,702, a lower figure compared to the same month of 2021, when it reached the value of -1,305. In the first eight months of 2022, the accumulated value of the natural balance was -29,871, improving the figure registered in the same period of 2021 (-33,052).

In August 2022, 4,860 marriages were celebrated, corresponding to an increase of 5.4% compared to the number of marriages held in August 2021 (248 more marriages). In the first eight months of 2022, 23,755 marriages were celebrated, 6,228 more than in the same period of 2021.

In this press release, Statistics Portugal provides **preliminary data** on the number of deaths per month until September 2022, and per week until the 39th week of 2022 (September 26th to October 2nd), and the number of live births and marriages per month until August 2022, that occurred in the national territory. The indicators published and analyzed in this Press Release are available on the Official Statistics Portal (<u>www.ine.pt</u>), with geographical breakdowns NUTS II and III. The hyperlinks to them can be found in the Excel file published together with this Press Release.

The information is obtained from the Sistema Integrado do Registo e Identificação Civil (SIRIC) until October 11th, 2022. The data presented regarding the number of deaths due to COVID-19, whose source is the report "Number of New Cases and Deaths Per Day" of the Directorate-General for Health, were extracted on October 11th, 2022.



In September 2022, mortality increased by 1.5% when compared to the same month of 2021

In September 2022, the number of deaths was 8,705, 576 fewer deaths than in the previous month. Compared to the same month of 2021, the number of deaths increased slightly (132 more deaths; 1.5%). The number of deaths due to COVID-19 decreased to 178 (50 less deaths compared to August 2022), accounting for 2.0% of all deaths. Compared to September 2021, there was a decrease of 45 deaths (-20.2%) due to COVID-19.




Figure 1. Deaths and year-on-year change, January 2019 to September 2022



Between January 31st and February 20th, 2022 (weeks 5 to 7), the number of deaths was higher than the average of the 5 years before the pandemic¹. Between February 21st and March 6th (weeks 8 and 9), the number of deaths returned to figures below the 2015-2019 average, as had already been registered in the last week of 2021 and the first four weeks of 2022. From March 7th to September 25th (weeks 10 to 38), the number of deaths was again above the average for the reference period (2015-2019).

In the 39th week of 2022 (September 26th to October 2nd), there were 1,892 deaths, a value close to the average for 2015-2019. The number of deaths due to COVID-19 was 46, accounting for 2.4% of all deaths.

¹ In this press release, to measure the variation in the number of deaths in relation to the pre-pandemic period, a simple calculation measure was adopted, using the average number of deaths for the five-year period 2015-2019 as basis for comparison. This measure should not, therefore, be confused with other indicators published in some studies, specially by the EuroMOMO platform. For more information see https://www.euromomo.eu/.

In the first nine months of 2022, there were 92,724 deaths, 1,186 fewer deaths than in the same period of 2021 (-1.3%).




Figure 3. Monthly deaths (cumulative values), 2019, 2020, 2021, and 2022

VITAL STATISTICS – Monthly Data – September 2022



The "excess mortality" indicator calculated by Eurostat, compares the number of deaths recorded each month, in the European Union (EU-27) and EFTA countries, with the average number of monthly deaths in the period 2016-2019. In 2022, Portugal recorded excess mortality in all months, except for January. In August 2022, excess mortality in the EU-27 and in Portugal decreased, respectively, to 12.0% and 9.2%.

In August 2022, respectively, 7,537 children were born alive, corresponding to an increase of 5.3% (378 more) when compared to the same month of 2021.





Figure 5. Live births and year-on-year change, January 2019 to August 2022

Figure 6. Monthly live births (cumulative values), 2019, 2020, 2021, and 2022




In August 2022, the natural balance was -1,702

In August 2022, the natural balance registered the value of -1,702, worsening when compared to that registered in the same month of 2021 (-1,305).

In the first eight months of 2022, the accumulated value of the natural balance was -29,871, improving the figure registered in the same period of 2021 (-33,052), though worsening when compared to the same period of 2019 (-19,166) and of 2020 (-23,763).

² The natural balance is calculated based on the number of live births of mothers residing in Portugal and the number of deaths of residents in Portugal.






Figure 8. Monthly natural balance (cumulative values), 2019, 2020, 2021, and 2022



In August 2022, celebrated marriages increased 5,4% compared to August 2021

In August 2022, 4,860 marriages were celebrated, corresponding to an increase of 5.4% regarding the number of marriages celebrated in August 2021 (248 more marriages).

In the first eight months of 2022, 23,755 marriages were celebrated, 6,228 more than in the same period of 2021, and 1,846 and 12,996 more than in the same months of 2019 and 2020, respectively.




Figure 10. Monthly marriages (cumulative values), 2019, 2020, 2021, and 2022

TECHNICAL NOTE

Statistics Portugal releases the **preliminary** monthly **numbers** of deaths, live births, and marriages based on the information registered in the Civil Register Offices until October 11th, 2022. Indicators on the preliminary monthly number of live births, deaths, and marriages, from January to August 2022, with geographical breakdowns up to NUTS 3, as well as weekly number of deaths, until the 39th week 2022, by NUTS 3 and daily number of deaths, until October 2nd, by NUTS 2 are made available on the Statistics Portugal Website.

Data are obtained from statistical operations of direct and exhaustive collection on live births, deaths and marriages in Portuguese territory using facts that are subject to compulsory civil registration (birth and death) in the Sistema Integrado do Registo e Identificação Civil (SIRIC).

In addition to administrative information obtained from Civil Register Offices, Statistics Portugal collects an additional set of variables identified as statistically pertinent to the National Statistic System (NSS) and the European Statistical System (EES).Data is recorded and sent electronically, in compliance with the requirements set out by Statistics Portugal and laid down in liaison with the Instituto de Registos e Notariado (IRN) and the Instituto de Gestão Financeira e Equipamentos da Justiça (IGFEJ).

Data on the number of deaths due to COVID-19 are also used, whose source is the "Number of New Cases and Deaths Per Day" Report of the Directorate-General for Health.

DEFINITIONS

Marriage: Contract signed by two persons that intend to start a family in full partnership and cohabitation according to legislation. Note: marriage can be held between persons from different or same sex.

Live birth: This is the complete expulsion or extraction from the mother's body, irrespective of the duration of the pregnancy, of a product of fertilization that, after separation, breathes or shows any other signs of life, such as a beating of the heart or umbilical cord or actual contraction of any muscle subject to voluntary movement, whether the umbilical cord has been severed and whether the placenta is retained.

Death: The permanent disappearance of vital functions.

Natural balance: The difference between the number of live births and the number of deaths during a given period, usually a calendar year.

Year-on-year change: The year-on-year change compares the level of a variable between the reference month and the same month of the previous year.

Excess mortality (source EUROSTAT, adapted): this indicator compares the number of deaths in each month, regardless of the cause of death, with that of a pre-pandemic reference period. In this case, the reference period consists of the average number of deaths that occurred in the month under analysis during the five-year period 2016-2019. When the indicator has a value greater than 100, it means that there were more deaths than in the reference period. In the case of a value lower than 100, this means that there were fewer deaths than in the reference period.
