



## Introduction

The **Mission** of Statistics Portugal is to produce, in an independent and impartial manner, high-quality official statistical information, relevant for society, promoting the coordination, analysis, innovation and dissemination of national statistical activity, ensuring the integrated storage of data. The dissemination of this information respects the principle of statistical confidentiality<sup>1</sup> as well as quality and impartiality criteria.

This tariff establishes the prices of products and services (customised information), and is organised as follows:

- " General Tariff Conditions
- » Customised information
- » Subscription service

Information on publications to be published on paper and made available on the Statistics Portugal's portal can be consulted in the Publications Catalogue.

## **General Tariff Conditions**

According to Article 8 - point 4 - of the National Statistical System Law Cn. O 22/2008 of 13 May) the "Access to official statistics associated with the provision of public service shall be ensured free of charge, unless it requires additional processing of the information".

In the Statistics Portugal's portal-www.ine.pt- all the information is free of charge.

The additional processing of information carried out by Statistics Portugal's technical staff (customised data collection) is considered as a service provision for which the following values are charged, including the VAT in force:

Design, Analysis or Programming	€ 40,00

Note: Service provision, except for the subscription service, with a value of €50 or less, are provided free of charge.

<sup>&</sup>lt;sup>1</sup> Statistical confidentiality (Law no. 22/2008, of 13 May - art. 6. The statistical confidentiality aims to safeguard the privacy and ensure the confidence of informants in the statistical system.



A discount may be applied to the value of the service provided and to the price (excluding postage costs) of the publications, depending on the type of customer: Teaching and Research as follows:

### **Physical variables**

- Legal entity no;
- Tradename of the company;
- Address of the company's registered office (including postcode and post town),
- Fax and URL of the website (these variables have a low level of completion);
- CAE Code (Rev. 3) up to 5 digits\*;
- NUTS and Municipality\*

<sup>\*</sup>free variable when provided together with other economic variables.



#### **Economic variables:**

- Products traded (CN Combined Nomenclature up to 8 digits and CAE/product up to 5 digits);
- Transaction flow (import and export);
- Country (of destination or origin);
- Mode of transport;
- Ranking (import/export volume).

The listings are available for full calendar years.

In cases where there is a cross between the variables "Products traded" and "Country", the complexity in applying the rules of confidentiality processing may not allow the provision of data in the required manner.

Prices for listings are calculated according to the number of records and the number of variables, as shown in the table below:
